Scottsdale Area Chamber / Blue Cross Blue Shield of AZ Individual Health Insurance Premium Discount

Blue Cross Blue Shield of AZ provides a premium discount for individual health insurance policies BluePreferred, BlueSelect, and BlueClassic for member businesses of the Scottsdale Area Chamber of Commerce.

Eligibility:

Full time and part time employees of a Scottsdale Area Chamber member business are eligible for the premium discount. An employee's spouse and children (to the age of 19 or age 25 if a fulltime student) are eligible. Even if the employee were not covered by a BCBSAZ individual health insurance policy, spouses and children covered by a BCBSAZ individual health insurance policy would be eligible for the premium discount.

Enrollment:

1. Existing BCBSAZ individual health insurance policyholders need to complete a Scottsdale Area Chamber / Blue Cross Blue Shield premium discount request form. The discount request form is submitted to Hawbaker, Hawbaker & Associates, Inc. for processing.
2. Individuals, families, or children applying for BCBSAZ individual health insurance need to complete a BCBSAZ individual insurance application and a Scottsdale Area Chamber / Blue Cross Blue Shield premium discount request form. The application and discount request form is submitted to Hawbaker, Hawbaker & Associates, Inc. for processing.

Health Insurance Coverage:

1. Existing BCBSAZ individual health insurance policyholders coverage remains the same as their current policy. There are no changes to their current BCBSAZ individual health insurance policy's benefits, limitations, or exclusions.
2. Applicants to BCBSAZ individual health insurance coverage can select from the three plans BCBSAZ offers for individual health insurance coverage.

Maintaining Premium Discount:

The insured maintains the premium discount as long as an employer that is a member of the SAC employs them. An insured is requested to notify BCBSAZ if no longer employed by SAC member. The employer is requested to notify BCBSAZ if SAC membership has terminated. A policyholder that no longer is eligible for the discount retains their individual health insurance coverage at the standard premium rate.
